Executive Summary:

On June 5, 2024, the California Underground Safety Board received termination notification email from Jim Schwilk, Vice President, with the Underground Service Alert of Southern California (DigAlert). The notification stated that on June 5, 2024, Washburn Grove Management, Inc. canceled its membership as an operator with DigAlert.

On June 5, 2024, Underground Service Alert of Southern California (DigAlert) submitted a notification of termination stating:

The case was assigned to Investigator Amy Morford (Investigator).

Identity of the Operator

Government Code section 4216(o) defines an operator to be "any person, corporation, partnership, business trust, public agency, or other entity that owns, operates, or maintains a subsurface installation."

Washburn Grove Management, Inc. (Washburn Grove Management) operates an eight-inch irrigation pipe located under Marshall Street in Hemet, California. Dennis Washburn is the agent of service of process for Washburn Grove Management. (Exhs. 2, 3.)

Washburn Grove Management, Inc.'s Operates a Subsurface Pressurized Irrigation Pipe Government Code section 4216(s) defines a subsurface installation as any underground pipeline, conduit, duct, wire, or other structure, except nonpressurized sewerlines, nonpressurized storm drains, or other nonpressurized drain lines.

Washburn Grove Management has one subsurface installation, an eight-inch irrigation pipe inside a twelve-inch pipe, located under Marshall Street in Hemet, California. The pipeline is used exclusively for irrigation on private property (citrus grove) and cannot be accessed without the operator's knowledge. (Exhs. 3, 4.)

On November 8, 2024, Investigator contacted Dennis Washburn, via phone, with follow-up questions. Mr. Washburn confirmed that the pipe under Marshall Street has pressurized water pumped through it. (Exh. 3.)

Investigator asked Mr. Washburn to estimate the length of the pipe under Marshall Road and the pressure running through the pipe. Mr. Washburn replied that the length of the pipe under the road was about sixty feet with about thirty to forty pounds of pressure. (Exh. 3.)

Washburn Grove Management, Inc.'s Termination of Membership

Government Code section 4216.1 states "every operator of a subsurface installation, except the Department of Transportation, shall become a member of, participate in, and share in the costs of, a regional notification center."

On November 5, 2024, Investigator interviewed, via phone, Dennis Washburn of Washburn Grove Management, regarding the membership termination with DigAlert, effective June 5, 2024. (Exh. 4.)

In summary, Mr. Washburn told Investigator that Washburn Grove Management joined DigAlert as an operator eight years ago because a pipeline was placed underneath a road. Washburn Grove Management has not sold its property or the subsurface installation. Washburn Grove Management has terminated their membership as they "[...] no use for them. I don't need them anymore. They've been bugging me for years, and I'll explain to you what I already explained to them. We did it so we wouldn't have to worry about the road. That's why we put the eight-inch inside the 12-inch line and ran it out of our property, so if it ever did leak, it wouldn't damage the road." (Exh. 4.)

On November 22, 2024, Investigator received ticket transmission information via email from Amber Dahl, Safety Awareness Director of DigAlert. In 2023, Washburn Grove Management received four new tickets and four renewal tickets. As of November 22, 2024, no DigAlert tickets had been transmitted to Washburn Grove Management during 2024. (Exh. 5.)

Findings:

1. Washburn Grove Management (Member code WASHBURN) is an operator of a subsurface installation and is required to participate in and share in the costs of a regional notification center.

Chair Muñoz and Members of the Underground Safety Board:

This correspondence is to advise you that Washburn Grove Mgmt. has terminated its membership with Underground Service Alert of Southern California (DigAlert). This termination is effective as of June 5, 2024.

As you are aware, California Government Code section 4216.1 requires every operator of a subsurface installation, except the Department of Transportation, to participate in, and share in the costs of, a regional notification center. Section 4216 *et seq.* does not confer any authority to regional notification centers to enforce the provisions of the Government Code, nor does it give the centers the authority to prevent a member from terminating its membership regardless of the circumstances. Furthermore, because DigAlert is a non-profit mutual benefit corporation, it is bound by the provisions of California Corporations Code section 7340(a) which provides that members may resign from membership at any time.

Therefore, in an effort to assist the Underground Safety Board (Board) in its role as an enforcement agency, as well as to further DigAlert's public safety goals, we requested information from Washburn Grove Mgmt. regarding the basis for termination of its membership with DigAlert. The terminating member provided us with the attached.



NARRATIVE:

On November 8, 2024, at approximately 12:21 a.m., the investigator spoke with Dennis Washburn of Washburn Grove Management regarding membership termination with Underground Service Alert of Southern California (DigAlert) effective June 5, 2024. The investigator had follow-up questions after speaking with Mr. Washburn on November 5, 2024.

INTERVIEW:

AM: Amy Morford - Investigator

OPR: Dennis Washburn, Washburn Grove Management (Washburn)

AM: Does the pipe under Marshall Street have water pumped through it?

OPR: "Yes."

AM: So the line is pressurized? OPR: "Yes, it has pressure."

AM: How much pressure is running through the pipe, in your estimation?

OPR: "About thirty to forty pounds of pressure."

AM: How long is the pipe under the section of the road?

OPR: "About sixty feet."

AM: And the pipe extends on both sides from Marshall Street on your private property, correct?

OPR: "Yeah, the water line is inside of another pipe, inside a sleeve. If something happens, the water won't blow out the road, it will blow out onto our property."

AM: The concern is if you sell the property there will be no record of the pipeline.

OPR: "When the grove is gone, the line will be shut down. It will be dead."

AM: Where is Marshall Street, what is it near when looking at a map?

OPR: "Highway 74. About a mile back from Fairview Avenue and Grant Street is nearby."

The investigator thanked Mr. Washburn and ended the call.

On November 5, 2024, at approximately 10:19 a.m., the investigator spoke with Dennis Washburn of Washburn Grove Management regarding membership termination with Underground Service Alert of Southern California (DigAlert) effective June 5, 2024.

INTERVIEW:

AM: Amy Morford - Investigator

OPR: Dennis Washburn, Washburn Grove Management (Washburn)

AM: Why did you become a DigAlert member?

OPR: "Eight years ago, we put a pipeline underneath the road. We put a pipe inside a bigger pipe, so that if it ever leaked, it wouldn't interfere with the road. They send me bills and I don't have anything I should be paying for."

AM: Does Washburn have subsurface installations in the ground?

OPR: "Yes, just one pipe, but it's nothing that's ever gonna interfere with the road."

AM: Is the pipe exclusive to Washburn Grove Management's property?

OPR: "Yeah."

AM: Do you still currently have subsurface installations in the ground?

OPR: "One pipe, just one pipe."

AM: Do you have more than one area where you've got subsurface installations in the ground?

OPR: "No."

AM: Okay, this one pipe, where is it located at?

OPR: "It's on Marshall Street. If you look at my records, it was an eight-inch line, and we put it in a 12-inch, so if we ever did have a leak on our pipeline, it would never interfere with the road."

AM: Do you have a street address? Where on Marshall Street?

OPR: "It's in my records, it's a farm, a citrus grove."

AM: Is the line exclusive to the farm? To your property?

OPR: "Yes."

AM: Can the line be accessed without your knowledge?

OPR: "No."

AM: "What is the line used for?

OPR: "It's for irrigation."

AM: So your only subsurface installation is an eight-inch irrigation line?

OPR: "Yes."

AM: Do you still own this line?

OPR: "Yes, we do."

AM: What is the reason you have terminated your membership?

OPR: "I have no use for them. I don't need them anymore. They've been bugging me for years, and I'll explain to you what I already explained to them. We did it so we wouldn't have to worry about the road. That's why we put the eight-inch inside the 12-inch line and ran it out of our property, so if it ever did leak, it wouldn't damage the road."

AM: The line is running underneath a road. Is this a county or city road?

OPR: "Yes."

AM: This is in Hemet?

OPR: "Yes."

The investigator thanked Mr. Washburn and ended the call.


