#### **Executive Summary:**

On December 11, 2023, Desert-Scape Management dug with shovels around an irrigation valve box without contacting the Regional Notification Center and damaged a natural gas facility owned by Southern California Gas Company.

#### **Investigation:**

#### **Notification of the Incident**

On December 11, 2023, the California Underground Safety Board received damage notification number 23NTS0015 from the Southern California Gas Company. The notification stated, "Contractor was hand digging to repair a water line, in the process contractor hit our gas service causing a gouge resulting in a gas leak." (Exh. 1.)

The case was assigned to Jeff McClenahan (Investigator).

#### **Identity of the Excavator**

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust, public agency, or other entity that, with their own employees or equipment, performs any excavation."

Desert-Scape Management is currently licensed by the California Contractors State License Board, license number 803949 a with C27-Landscaping Classification. (Exh. 2.)

#### **Identity of the Operator**

Government Code section 4216(o) defines an operator to be "any person, corporation, partnership, business trust, public agency, or other entity that owns, operates, or maintains a subsurface installation."

Within the Southern California Gas Company's initial damage report submitted to the Board, the description of the observed excavation activities was: "Contractor was hand digging to repair a water line, in the process contractor hit our gas service causing a gouge resulting in a gas leak." This confirms Southern California Gas Company is the operator of the damaged service line. (Exh. 1.)

#### **Excavation and Damage**

On January 16, 2024, Investigator had a telephone interview with Saul Serrato, owner of Desert-Scape Management. During the interview, in summary, Mr. Serrato stated that Desert-Scape Management:

- Dug around valve boxes with shovels to replace a valve.
- Did not call 811 and it would be unusual to call 811 when they were just digging around a box with shovels and replacing a valve.
- Dug near a tree and the gas line looked like a tree root.
- Would answer questions when they go back to the office that were sent to Martin. (Exh. 3)

### <u>Desert-Scape Management Excavated Without First Contacting the Regional Notification</u> Center

Government code section 4216.2(b) requires an excavator to first contact a Regional Notification Center prior to excavating.

During the January 16, 2024, telephone interview between Saul Serrato, owner of Desert-Scape Management and Investigator, Mr. Serrato stated that Desert-Scape Management did not obtain a ticket prior to excavation on December 11, 2023. (Exh. 3.)

On June 10, 2024, Investigator emailed Amber Dahl, Safety Awareness Director at DigAlert requesting her assistance in searching for tickets for Desert-Scape Management from January 1, 2023 through December 31, 2023, for 74776 Casandra Court, Indian Wells, California 92210. (Exh. 4.) On June 10, 2024, Amber Dahl emailed Investigator that the ticket search for 74776 Casandra Court Indian Wells, California 92210 resulted in 3 nearby tickets A232620059, B232640743, B233010008. None of the tickets were for 74776 Cassandra Court or for Desert-Scape Management. (Exh. 5).

#### <u>Desert-Scape Management Did Not Call 911 Emergency Services upon Gas Release</u>

Government Code section 4216.4(c)(1) states an excavator shall call 911 emergency services upon discovering or causing damage to a gas or hazardous liquid pipeline subsurface installation in which the damage results in the escape of any flammable, toxic, or corrosive gas or liquid.

On December 11, 2023, Southern California Gas Company learned of an excavation damage when Desert-Scape Management, while using a shovel, damaged a natural gas facility that caused a gas release to leak at 74776 Casandra Court, Indian Wells California 92210 on December 11, 2023. (Exh. 1).

On February 6, 2025, the investigator contacted the Riverside County Sheriff's Office regarding a dispatch logs, incident reports, or audio recordings for a natural gas dig-in at 74776 Casandra Court, Indian Wells California 92210 on December 11, 2023. (Exh. 11, 12.)

On February 6, 2025, the Riverside County Sheriff's Office responded that they reviewed the request and determined "there are no records responsive" to the request. (Exh. 12.)

#### <u>Desert-Scape Management Did Not Respond to Information Requests</u>

On January 3, 2024, Investigator sent a Case Announcement and an Information Request, via email, to Desert-Scape Management. Additionally, the accompanying email contained a series of questions needing responses as part of the request. The Information Request contained a response due date of January 12, 2024. (Exh. 6, 7, 8.)

During the January 16, 2024, telephone interview at 2:00 p.m. in the afternoon, between Saul Serrato, owner of Desert-Scape Management, and Investigator, Mr. Serrato stated they would respond to the Investigator's remaining questions. (Exh. 3.)

Investigator sent a 2<sup>nd</sup> Information Request, via email, to Desert-Scape Management on January 16, 2024, as no response to the original Information Response had been received by its due date of January 12, 2024. The 2<sup>nd</sup> Information Request had a response date of January 26, 2024. (Exh. 9, 10.)

This 2<sup>nd</sup> Information Request was sent the same day Investigator spoke with Mr. Serrato and was told he would receive answers to his original questions. It was emailed at 7:16 p.m. at night, approximately five hours after being told his questions would be answered. As of the date of this Report of Investigation, Desert-Scape Management has not answered Investigator's remaining questions or either Information Request.

#### **Findings:**

- 1. On December 11, 2023, Desert-Scape Management excavated with shovels and damaged a natural gas facility without first contacting the Regional Notification Center.
- 2. Desert-Scape Management did not respond to information requests regarding the damage that occurred on December 11, 2023, at 74776 Casandra Court, Indian Wells, California 92210.
- 3. Desert-Scape Management did not contact 911 following the natural gas dig-in and gas release that occurred on December 11, 2023, at 74776 Casandra Court, Indian Wells, California 92210.






