Executive Summary:

On July 26, 2024, Artistry Development dba Artistry Pools damaged a half-inch plastic gas service line with a shovel while digging a trench to install irrigation water lines. Artistry Pools did not contact the regional notification center before digging.

After damaging the line, Artistry Pools did not call 911 emergency services to report it.

No one was injured and no equipment, other than the half-inch plastic gas service line was damaged.

Investigation:

Notification of the Incident

On September 5, 2024, at 2:28 pm, the Southern California Gas Company submitted a notification of an incident to the California Underground Safety Board. The notification stated, "Artistry pools trenched with hand tools to install irrigation, struck 0.5-inch plastic gas service while digging without a USA. Contractor taped and wire clamped plastic service to attempt to stop gas flow." (Exh. 1.)

The case was assigned to Investigator Adrian Anaya (Investigator).

Excavation and Identity of the Excavator

Government Code section 4216(g) defines "excavation" to be the use of tools or equipment to move or displace earth, rock, or other material in the ground.

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust, public agency, or other entity that, with their own employees or equipment, performs any excavation."

On July 26, 2024, Artistry Development dba Artistry Pools (Artistry Pools) was digging a trench with a shovel and damaged a half-inch gas line while installing irrigation water lines at 11369 Brill Drive, Studio City, California 91604. (Exh. 1.)

Artistry Pools is currently licensed by the California Contractor's State License Board, license number 1097346 with C53-Swimming Pool Classification. (Exh. 3.)

Artistry Pools Did Not Contact the Regional Notification Center Before Excavating

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

Artistry Pools did not notify the regional notification center before digging the trench. Cody William Moore, Reporting Managing Officer of Artistry Pools, stated that the company did not contact the regional notification center because he "had the understanding that anything over 24 inches needed 811 called in". (Exh. 2.)

On October 25, 2024, Investigator emailed Amber Dahl (Dahl), Safety Awareness Director at Underground Service Alert of Southern California (DigAlert), requesting ticket information for 11369 Brill Drive Studio City, California 91604, on July 26, 2024. (Exh. 4.)

Dahl responded on October 28, 2024, confirming that a ticket did not exist for the location of 11369 Brill Drive, Studio City, California 91604, before the gas service line was damaged on July 26, 2024, at approximately 2:40 pm. (Exh. 5.)

Artistry Pools Contacted the Regional Notification Center After the Damage Occurred

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

On December 4, 2024, Investigator emailed Amber Dahl (Dahl), Safety Awareness Director at Underground Service Alert of Southern California (DigAlert), requesting ticket information for 11369 Brill Drive Studio City, California 91604, for July 27, 2024, through August 1, 2024. (Exh. 6.)

That same day, Dahl responded with a copy of DigAlert ticket A242131034. Ticket A242131034 was created by Cody Moore with Artistry Pools on July 31, 2024, and contained a comment stating, "from the existing trench across the F-Yard of address, mainly concerns with gas. Area will be delineated by tomorrow 08/01/24. Work has already started 07/31/24." No other tickets were provided by Dahl. (Exh. 7.)

Artistry Pools did not call 911 emergency services upon gas release

Government Code section 4216.4(c)(1) states an excavator shall call 911 emergency services upon discovering or causing damage to a gas or hazardous liquid pipeline subsurface installation in which the damage results in the escape of any flammable, toxic, or corrosive gas or liquid.

Artistry Pools did not call 911 after damaging the gas line. (Exh. 2.)

On December 9, 2024, Investigator emailed the Los Angeles Fire Department Records to request a fire report at 11369 Brill Drive Studio City, California 91604, on July 26, 2024. (Exh. 8.) On December 9, 2024, and December 18, 2024, the Los Angeles Fire Department confirmed no fire report existed for the incident on July 26, 2024. (Exh. 9.)

Findings:

- 1. Artistry Pools failed to contact the regional notification center before digging on July 26, 2024, at 11369 Brill Drive Studio City, California 91604.
- 2. On July 26, 2024, Artistry Pools failed to call 911 emergency services after damaging the gas line.







My understanding was that the city gas lines run perpendicular from the street to the gas meter. The gas meter was on the other side of the property where we were trenching. It never crossed my mind to call in 811 for basic shallow trenching.
