## **Executive Summary:**

On October 07, 2024, at 1:40 p.m., HTA Construction & Development excavated without first contacting the Regional Notification Center, and with a shovel, damaged a 1 ½" plastic natural gas facility while trenching for a water service. After damaging the gas line, HTA Construction & Development contacted the operator but did not call 911 emergency services. No one was injured and no equipment, other than the natural gas facility, was damaged.

# Investigation:

# **Notification of the Incident**

On November 11, 2024, at 10:17 a.m., Southern California Gas Company submitted a notification of an incident to the California Underground Safety Board. The notification stated that, on October 7, 2024, in Costa Mesa a "[c]ontractor hit our line because they did not have a USA ticket". (Exh. 1.)

The case was assigned to Investigator Angel Barton (Investigator).

# Identity of the Excavator, Excavation, and Damage to the Gas Line

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust, public agency, or other entity that, with their own employees or equipment, performs any excavation."

On October 7, 2024, at approximately 1:40 p.m., HTA Construction & Development damaged a gas line while digging at 1769 Anaheim Avenue, Costa Mesa, California 92627. Brady Carbajal, project manager, stated the damage occurred "while excavating around the gas line [a] shovel accidentally nicked the gas line." (Exh. 2.)

HTA Construction & Development was licensed, as of November 27, 2024, by the California Contractors State License Board, license number 1044038 with a B – General Building Classification. (Exh. 3.)

# HTA Construction & Development Did Not Contact the Regional Notification Center Before Excavating

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

HTA Construction & Development did not notify the Regional Notification Center before digging at 1769 Anaheim Avenue, Costa Mesa, California 92627, on October 7, 2024. (Exh. 2.)

On November 26, 2024, Investigator emailed Safety Awareness Director Amber Dahl of DigAlert, requesting ticket information for 1769 Anaheim Avenue, Costa Mesa, California 92627, for September 7, 2024, through October 25, 2024. (Exh. 4.)

Dahl responded on November 27, 2024, confirming that a ticket did not exist for 1769 Anaheim Avenue, Costa Mesa, California 92627 from September 7, 2024, through October 25, 2024. (Exh. 5.)

# HTA Construction & Development Did Not Call 911 Emergency Services After Damaging the Line

Government Code section 4216.4(c)(1) states an excavator shall call 911 emergency services upon discovering or causing damage to a gas or hazardous liquid pipeline subsurface installation in which the damage results in the escape of any flammable, toxic, or corrosive gas or liquid.

On October 7, 2024, at approximately 1:40 p.m., while using a shovel, HTA Construction & Development damaged a 1 ½" plastic natural gas facility. The damage caused gas to leak but no one with HTA Construction & Development called 911 to report it. (Exh. 2.)

# Findings:

- 1. On October 7, 2024, at 1769 Anaheim Avenue, Costa Mesa, California 92627, HTA Construction & Development dug with a shovel and damaged a gas line without first contacting the Regional Notification Center.
- 2. After damaging the line, HTA Construction & Development failed to call 911 emergency services to report the damage.
