Subject: Third Revised 2026-2028 Base Wildfire Mitigation Plan Schedule

Dear Wildfire Mitigation Plan Stakeholders:

The Office of Energy Infrastructure Safety (Energy Safety) is revising the Submission and Evaluation Schedule for 2026-2028 Base Wildfire Mitigation Plans (2026-2028 Base WMPs), as provided in Attachment 1. This revision includes the changes from the schedule published on May 14, 2025.¹

During its evaluation of the 2026-2028 Base WMP submissions, Energy Safety identified multiple instances in which electrical corporations' WMPs either did not meet or conform to the requirements of Energy Safety's WMP Guidelines, and instances of critical issues that had to be addressed before Energy Safety could continue its evaluation.² As a result, Energy Safety issued a Rejection and Order to Resubmit to San Diego Gas and Electric Company³ and Revision Notices to both Pacific Gas and Electric Company⁴ and Southern California Edison.⁵

Issuance of the aforementioned Rejection and Order to Resubmit and Revision Notices took significant time and resources from Energy Safety during its evaluation period for some

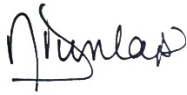
electrical corporations and delayed Energy Safety from continuing its evaluation until it received additional or revised information for others.
