Regarding Aerial Suppression Resources:

On page 438 of SCE's 2026-2028 Base WMP, SCE discusses its Memorandums of Understanding (MOU) with local county firefighting agencies to provide aerial firefighting resources.

a. Specify the aerial suppression resources that are funded through SCE's agreement with Los Angeles, Ventura, and Orange Counties that are used to expand quick reaction force coverage from 165-days to year-round.

Response to Question 02:

SCE's agreements with Los Angeles and Ventura County fund a CH47 or its equivalent capable of nighttime operations and equipment and personnel related to the operation and maintenance of such aircraft.

SCE's agreement with Orange County funds a CH47 and an S76 aerial supervision helicopter or their functional equivalents, one Mobile Retardant Base, and an OCFA program manager to manage the Fire Suppression Assets and qualified aerial supervisors.

On page 453 of SCE's 2026-2028 Base WMP, SCE states that the Emergency Outage Notifications System (EONS) provides PSPS notification translations in 23 languages.
