

Trans Bay Cable LLC's Application for Confidential Designation Pursuant to California Code of Regulations §29200

I, Lenneal Gardner, declare and state:

1. I am a Senior Manager Regulatory Affairs at NextEra Energy Transmission, LLC supporting affiliate Trans Bay Cable LLC (TBC). I am responsible for overseeing and reviewing TBC's confidential materials in connection with TBC's 2026-2028 Base Wildfire Mitigation Plan and related Data Request Responses submitted to the Office of Energy Infrastructure Safety (Energy Safety). I am authorized to request confidential treatment via this application on behalf of TBC.
2. I am making this declaration pursuant to California Code of Regulations Title 14, Division 17, Chapter 1, Article 3, § 29200 and in accordance with the confidentiality bases set forth and applicable California Public Utilities Commission precedent that govern the submission of confidential documents. TBC discloses this information pursuant to these bases as confidential materials and has not disclosed the information publicly.
3. The information/data covered by these confidentiality bases as described in the following paragraphs is not customarily in the public domain.
4. One unredacted copy of the record containing the confidential information is included with this submission.
5. The information has critical infrastructure information and/or critical electric infrastructure information. The release of the precise location, age, condition, other attributes of TBC's assets, in addition to the methods of operations and maintenance of said assets may significantly increase safety risk to the public.
6. The information/data should be kept confidential indefinitely.
