

Southern California Edison Company's Application for Confidential Designation
Pursuant to California Code of Regulations § 29200

I, Raymond Fugere, declare and state:

1. I am the Director of Asset & System Intelligence at Southern California Edison Company (SCE). As such, I am responsible for overseeing and reviewing SCE's confidential materials in connection with SCE's 2023-2025 Wildfire Mitigation Plan and related Data Requests submitted to the Office of Energy Infrastructure Safety (OEIS). I am authorized to request confidential treatment via this application on behalf of SCE.

2. I am making this declaration pursuant to California Code of Regulations Title 14, Division 17, Chapter 1, Article 3, § 29200 and in accordance with the confidentiality bases set forth and applicable California Public Utilities Commission's precedent that govern the submission of confidential documents. SCE discloses this information pursuant to these bases as confidential materials and has not disclosed the information publicly.

3. The data covered by these confidentiality bases as described in the following paragraphs is not customarily in the public domain.

4. The data covered by these confidentiality bases contains trade secret information associated with proprietary processes developed by SCE relating to SCE's Wildfire Mitigation Plan and thus would provide a competitive advantage if disclosed.

5. Disclosure of the data covered by these confidentiality bases would allow others to copy and use the proprietary processes developed by SCE, which would result in a loss of competitive advantage.

6. It would be difficult for others to acquire or duplicate the data covered by these confidentiality bases, as SCE has expended significant resources developing its proprietary processes.

7. One unredacted copy of the record containing the confidential information is included with this submission.

8. The data should be kept confidential indefinitely.
