#### **Executive Summary:**

On the morning of November 29, 2023, A G Vinyl Fencing, Inc. was using a manual post-hole digger to replace a fence when they struck a ½" plastic service natural gas facility at 2547 North Capri Street, Orange, California 92865. A G Vinyl Fencing, Inc. began digging for the fence work without first notifying the regional notification center.

At 12:56 p.m. that same day, Southern California Gas Company notified the regional notification center for the emergency leak repair on North Capri Street, Orange, California 92865.

The City of Orange – Water did not provide an electronic positive response to the ticket for Southern California Gas Company.

### **Investigation:**

#### **Notification of the Incident**

On December 11, 2023, at 11:25 a.m., the California Underground Safety Board (Board) received a notification from Southern California Gas Company. The notification stated, "Third-party contractor excavating to install a fence post struck and damaged half inch plastic service." (Exh. 1.)

The case was assigned to Investigator Jeff McClenahan (Investigator).

#### **Identity of the Excavator**

Government Code section 4216(g) defines "excavation" to be the use of tools or equipment to move or displace earth, rock, or other material in the ground.

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust, public agency, or other entity that, with their own employees or equipment, performs any excavation."

On February 15, 2024, Investigator had a telephone interview with Armen Andreasyan, "foreman" at A G Vinyl Fencing, Inc., who stated, in summary, that he had been at 2547 North Capri Street to install a fence and acted as the foreman. Andreasyan was off site when the crew called him about a gas leak. They were replacing an old fence and installing a new one by placing new posts in the same places as the old ones. The gas line was directly under the

post and while clearing the hole, the crew heard a pop of a white PVC plastic facility. Andreasyan had never seen a gas line like that and said it looked like an irrigation line. (Exh. 2.)

A G Vinyl Fencing, Inc. was licensed, as of July 25, 2024, by the California Contractors State License Board, holding license number 1059119, with C13-Fencing, C-61/D41-Siding and Decking, and C-61/D03 – Awning classifications. (Exh. 3.)

## A G Vinyl Fencing, Inc. Did Not Contact the Regional Notification Center Before Excavating

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

On February 15, 2024, Investigator had a telephone interview with Armen Andreasyan, "foreman" at A G Vinyl Fencing, Inc. who stated that they do not notify the regional notification center for fence replacements and they did not notify the regional notification center for the fence installation on November 29, 2023. (Exh. 2.)

Sean O'Connor of Southern California Gas Company reported that A G Vinyl Fencing was excavating to install a fence post with a shovel when they damaged the natural gas facility. (Exh. 1.)

On February 20, 2024, DigAlert's Safety Awareness Director, Amber Dahl emailed Investigator ticket search results for 2549 North Capri Street, Orange, California 92865, between October 1, 20203, and December 31, 2023. The ticket search results contained a ticket created by Southern California Gas Company for the emergency leak repair, ticket B233330560-00B through 02B, at 2547 North Capri Street. (Exh. 4.)

This ticket search results provided by Director Amber Dahl did not include a ticket for A G Vinyl Fencing, Inc. (Exh. 4.)

#### There was an Emergency Response to the Natural Gas Release

On April 16, 2025, Investigator emailed a public records request to the City of Orange regarding an emergency response to the gas release on November 29, 2023, at 2547 North Capri Street, Orange, California 92865. (Exh. 9)

On April 24, 2025, the City of Orange Fire Department responded by email with a copy of dispatch logs and two audio files confirming that there was an emergency response to the gas release on November 29, 2023. (Exh. 9.)

A resident at 2547 North Capri Street called the fire department. (Exh. 9.)

# <u>City of Orange – Water Did Not Provide an Electronic Positive Response to Ticket</u> B233330560-00B

Government Code section 4216.3(c)(1)(A) states that every operator shall supply an electronic positive response through the regional notification center before the legal excavation start date and time.

Southern California Gas Company notified DigAlert for ticket B233330560-00B for the emergency leak repair to the natural gas damage at 2547 North Capri Street, Orange, California 92865, on November 29, 2023. (Exh. 4.)

Ticket number B233330560-00B required a response from operators and indicated the legal excavation start date and time of December 1, 2023, at 5:01 p.m. (Exh. 4.)

On December 1, 2023, at 5:01 p.m., the City of Orange - Water (Member code ORA01) received late notice electronic positive response code 999 from the regional notification center. (Exh. 4.)

On September 5, 2024, Investigator emailed Safety Awareness Director Amber Dahl at DigAlert, requesting the contact details for the City of Orange – Water (ORA01). (Exh. 5.) That same day, September 5, 2024, Director Amber Dahl confirmed the contact for the City of Orange - Water as "Main is Tuan Cao is 714981-6403, usa@cityoforange.org." (Exh. 5.)

On September 5, 2024, Investigator emailed an Information Request to the City of Orange - Water regarding the late notice electronic positive response code. It had a response due date of September 20, 2023. (Exhs. 6, 7.) There was no response.

On October 9, 2024, Investigator emailed a second Information Request to the City of Orange - Water . (Exhs. 6, 8.)

The City of Orange did not respond.

#### **Findings:**

- 1. A G Vinyl Fencing, Inc. damaged an ½" plastic service natural gas facility while excavating with a manual post-hole digger to install a fence post at 2547 North Capri Street, Orange, California, 92865.
- 2. City of Orange Water did not provide an electronic positive response code to ticket B233330560-00B prior to the legal excavation start date and time.
- 3. There was an emergency response to the natural gas damage with gas release at 2547 North Capri Street following the resident of that address calling 911.



Damage on November 29, 2023

We are talking about 2549 North Capri Street that I emailed about; you recall that project?

Yes.

#### Were you there on this project?

Yeah, was there were in the morning, left and when the guys called about the gas I returned to the site.

#### Role on the project?

Owners son, handle all installation and scheduling, manage 7 teams, you can say foreman.

#### What happened?

Will call 811 when digging in front of a home. Any new fences will call 811 and have them mark everything out for us. Have had cases where water mains were marked and were incorrect.

This one was something different. First ever. When replacing an old fence and installing a new, we don't call 811. Just putting a post into the same spot.

Gas line was directly under the post. Removed old post and footing, made a bit wider, clearing out the hole and pop a plastic hose. Thought were steel or with orange covering. Was a straight white PVC. Never seen a gas line like that. White color like an irrigation line. In the repairs SoCal Gas changed new pipe, to a yellow pipe.

I got the call and said I would call SoCal Gas and I was going to call 911 but SoCal Gas already called 911.

Assumed since the post has been there and that right under it wouldn't think under that footing was a gas line.

#### And you showed up after the damage?

Yeah. And then after that brought over 4 more guys to finish the project.

#### Were you aware of the 811 system?

I know they mark out from the front of the house to the utilities. Have had my share of calls and used the online system.

## Do you know if the homeowner called in a ticket?

After the fact the homeowner did.

## Did the utility offer you any training or anything after the fact?

No, would have loved to have a company-wide course like a friend's company did.
