Executive Summary:

On August 22, 2024, Grey-Con Construction Inc., dba Grey-Con Landscape Construction Inc. excavated without first contacting the regional notification center, and with a pick, damaged a one-inch and a half plastic natural gas pipeline while trenching to install hardscape. Upon the escape of gas from the subsurface installation, Grey-Con Construction Inc. did not contact 911 emergency services to report it. No one was injured, and no equipment, other than the inch-and-a-half plastic natural gas pipeline, was damaged.

During the course of the investigation, the prime contractor, South Pointe Construction LLC, did not respond to the investigator's information request letters.

Investigation:

Notification of the Incident

On September 5, 2024, Southern California Gas Company submitted a notification of an incident to the California Underground Safety Board. The notification stated, "Contractors were digging without a USA and hit our service with a shovel. There were marks from an old USA and they were good." (Exh. 1.)

The case was assigned to Investigator Adrian Anaya (Investigator).

Excavation and Identity of the Excavators

Government Code section 4216(g) defines "excavation" to be the use of tools or equipment to move or displace earth, rock, or other material in the ground.

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business

trust, public agency, or other entity that, with their own employees or equipment performs any excavation."

Regarding licensed contractors, Business and Professions Code section 7068.1 makes a contractor responsible for the conduct of its subcontractors. At subdivision (a), section 7068.1 states, in part, "The person qualifying on behalf of an individual or firm ... shall be responsible for exercising supervision and control of their employer's or principal's construction operations to secure compliance with this chapter and the rules and regulations of the board."

Section 7068.1 defines "supervision and control" to mean "direct supervision or control or monitoring and being able to assist others to whom direct supervision and control has been delegated." (Bus. & Prof. Code section 7068.1(c)(3).) Further, "direct supervision or control" means any of the following:

- (A) Supervising construction operations.
- (B) Managing construction activities by making technical and administrative decisions.
- (C) Checking jobs for proper workmanship.
- (D) Supervision on construction sites. (Bus. & Prof. Code section 7068.1(c)(4).)

Further, licensed contractors are required to comply with dig-safe laws by Business and Professions Code section 7110, which makes violation of the dig-safe laws a cause for disciplinary action. Section 7110(f) states that "[w]illful or deliberate disregard and violation of the building laws of the state, or of any political subdivision thereof, or of any of the following references to or provisions of law, constitutes a cause for disciplinary action against a licensee: (f) Any provision of Article 2 (commencing with Section 4216) of Chapter 3.1 of Division 5 of Title 1 of the Government Code."

Grey-Con Construction Inc. was hired by South Point Construction LLC to install hardscape for a driveway at 4827 Dorchester Road, Corona Del Mar, California 92625. On August 22, 2024, Grey Con Construction Inc. damaged a natural pipeline with a shovel.

Prime Contractor South Pointe Construction LLC

South Pointe Construction LLC hired Grey-Con Construction Inc. (Grey-Con) to install hardscape for the driveway. (Exh. 2.)

South Pointe Construction LLC is currently licensed by the California Contractor's State License Board, as of April 7, 2025, holding license number 989405 with a B-General Building Classification. (Exh. 3.)

During the investigation, the investigator emailed and mailed information requests, IR-2025-261 and IR-2025-2-114, to South Pointe Construction LLC. However, South Pointe Construction LLC did not respond to the investigator's information request. (Exhs. 4, 5.)

On September 12, 2025, the investigator performed a telephone call to South Pointe Construction LLC at the business number listed on the California Contractor's State License Board website. However, the number was no longer in service. (Exh. 6.)

Sub Contractor Grey-Con Construction Inc.

Grey-Con was digging to install hardscape at 4827 Dorchester Road, Corona Del Mar, California 92625, on August 22, 2024, when the natural gas pipeline was damaged with a shovel. (Exhs. 1, 2.)

Grey-Con is licensed by the California Contractors State License Board, as of December 3, 2024, holding license number 329260, with a C27 – Landscaping classification. (Exh. 7.)

Grey-Con Did Not Contact the Regional Notification Center Before Excavating

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

Grey-Con did not notify the regional notification center prior to excavation. Jeffrey Thomas Greyson, Reporting Managing Officer, Chief Executive Officer, and President of Grey-Con, indicated during his telephone interview with the investigator on December 13, 2024, that the reason he did not contact the regional notification center before excavating was due to the lack of information for his employee to contact the regional notification center prior to excavating. (Exh. 2.)

The Southern California Gas Company indicated in the notification they submitted to the Board that there were marks from a previous ticket. (Exh. 1.)

On December 30, 2024, Investigator emailed Amber Dahl, Safety Awareness Director at the Underground Service Alert of Southern California (DigAlert), requesting ticket information for 4827 Dorchester Road, Corona Del Mar, California 92625, for August 22, 2024. (Exh. 8.)

Safety Awareness Director Amber Dahl responded by email that same day, providing a copy of a ticket associated with 4827 Dorchester Road, Corona Del Mar, California 92625. However, the ticket contained a different business entity, CAL Empire Engineering, as the excavator and did not include Grey-Con. No other tickets were located for February 22, 2024, through August 22, 2022. (Exh. 9.)

Grey-Con Did Not Contact 911 Emergency Services After Damaging the Line

Government Code section 4216.4(c)(1) states an excavator shall call 911 emergency services upon discovering or causing damage to a gas or hazardous liquid pipeline subsurface installation in which the damage results in the escape of any flammable, toxic, or corrosive gas or liquid.

On December 13, 2024, Jeffrey Thomas Greyson, President of Grey-Con, indicated during his telephone interview with the investigator that, while his employee was using a pick on August 22, 2024, Grey-Con damaged a plastic natural gas pipeline by excavating to install hardscape, which caused gas to leak, but did not contact 911 afterward. Jeffrey Thomas Greyson stated he did not contact 911 because he did not know he had to. (Exh. 2.)

On January 13, 2024, the Investigator emailed the Newport Beach Fire Department to request a fire report for 4827 Dorchester Road, Corona Del Mar, California 92625 for August 22, 2024. On January 27, 2024, the Newport Beach Fire Department responded electronically, confirming no reports were located. (Exh. 10)

South Pointe Construction LLC Did Not Contact the Regional Notification Center Before Excavating

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

South Pointe Construction LLC did not notify the regional notification center prior to their sub-contractor, Grey-Con, excavation at 4827 Dorchester Road, Corona Del Mar, California 92625, on August 22, 2024. (Exh. 1.)

Amber Dahl with DigAlert provided the investigator with tickets between the dates of February 22, 2024, through August 22, 2024, where no tickets were provided for Grey-Con when they excavated on August 22, 2024. The reason South Pointe Construction LLC did not notify the regional notification center prior is unknown due to not responding to the investigator's information requests IR-2025-261 and IR-2025-2-114. (Exhs. 4, 5.)

<u>South Pointe Construction LLC Refused to Cooperate with the Board's Investigation</u>
California Code of Regulations, Title 19, section 4151(c) provides that an excavator "who obstructs an investigation by taking actions that were known or reasonably should have been

known to prevent, hinder, or impede an investigation is subject to sanctions under the Act and this division."

On August 6, 2025, Investigator emailed and mailed information request IR-2025-261 to South Pointe Construction LLC. A scheduled response due date was set for August 21, 2025. (Exh. 4.)

The United States Postal Service tracking history indicated information request IR-2025-261 was delivered to the front desk of South Pointe Construction LLC's business address at 12:29 p.m. on August 18, 2025. (Exh. 4.)

On August 25, 2025, Investigator emailed and mailed a 2nd information request, IR-2025-2-114, due to not receiving a response for the first information request, IR-2025-162. A scheduled response due date was set for September 1, 2025. (Exh. 5.)

The United States Postal Service tracking history indicated information request IR-2025-2-114 was unable to be delivered and was returned to the original sender on September 5, 2025. (Exh. 5.)

On September 12, 2025, the investigator attempted to call South Pointe Construction LLC at the business number listed on the Contractor State License Board website. However, the phone number was no longer in service, and voicemail was unable to be delivered. (Exh. 6.)

As of the writing of this Report of Investigation, no information has been provided by South Pointe Construction LLC to the investigator's information requests.

Findings:

- 1. Grey-Con failed to contact the regional notification center before beginning excavation on August 22, 2024, at 4827 Dorchester Road, Corona Del Mar, California 92625 due to the lack of information to its employee.
- 2. Grey-Con failed to contact 911 emergency services to report the escaping gas from the subsurface installation after it was damaged while trenching to expose a facility because the President of Grey-Con did not know he had to contact 911.
- 3. South Pointe Construction LLC failed to contact the regional notification center prior to their sub-contractor beginning excavation on August 22, 2024, at 4827 Dorchester Road, Corona Del Mar, California 92625.
- 4. South Pointe Construction LLC did not respond to the investigator's information request letters.



INTERVIEW:

On December 13, 2024, at 9:49 am, Investigator Adrian Anaya (Investigator) received a call from Jeffrey Thomas Greyson (Greyson), Responsible Manager Officer, Chief Executive Officer and, President of Grey-Con Construction Inc dba Grey-Con Landscape Construction Inc, Contractor State License Number 329260, at (951) 541-8312 as listed on the Contractor State License Board (CSLB) website. Greyson confirmed his business address of 22858 Hunwut Drive, Wildomar, California 92595, which matches the address on CSLB's website. Greyson confirmed he received the email that was sent to him from the Investigator. Greyson answered yes to if Grey-Con Construction excavated and damaged the plastic gas line at 4827 Dorchester Road, Corona Del Mar, California 92625 on August 22, 2024. Greyson stated that one of his laborers hit the line and that it was three feet away from the house where the line was. Greyson stated he was not at the job site, and he received a call from his laborers to let him know about the damage. Greyson indicated the line was about 10-12 inches deep. Greyson reported that the laborer no longer works for him and does not remember the name. Grey indicated that a pickaxe was used during the incident, and his company owns the pickaxe. Greyson stated that 811 was not contacted due to the lack of information to his employee. Greyson indicated the prime contractor did not mention contacting 811, and he is aware that 811 is required before you dig.

Greyson stated they were doing the hardscape for the concrete and driveway. Greyson indicated he was hired by South Point Construction to perform the work and does not know if other companies were on site when the incident occurred since he was not there. Greyson indicated South Point Construction was the general contractor. Greyson stated his employees called the gas company after the damage occurred. Greyson indicated 911 was not called because he was

not aware 911 needed to be called. Greyson stated no damages were reported to 811 and that he doubts if anyone else contacted 811 after the damage. Greyson confirmed no injuries, no deaths, or evacuations occurred. Greyson stated his employees crimped the pipe and taped it so that the gas stopped. Greyson reported the gas company came to repair it based on what he remembered and that the work has been completed.



Executive Summary:

On August 22, 2024, Grey-Con Construction Inc., dba Grey-Con Landscape Construction Inc. excavated without first contacting the regional notification center, and with a pick, damaged a one-inch and a half plastic natural gas pipeline while trenching to install hardscape. Upon the escape of gas from the subsurface installation, Grey-Con Construction Inc. did not contact 911 emergency services to report it. No one was injured, and no equipment, other than the inch-and-a-half plastic natural gas pipeline, was damaged.

During the course of the investigation, the prime contractor, South Pointe Construction LLC, did not respond to the investigator's information request letters.

Investigation:

Notification of the Incident

On September 5, 2024, Southern California Gas Company submitted a notification of an incident to the California Underground Safety Board. The notification stated, "Contractors were digging without a USA and hit our service with a shovel. There were marks from an old USA and they were good." (Exh. 1.)

The case was assigned to Investigator Adrian Anaya (Investigator).

Excavation and Identity of the Excavators

Government Code section 4216(g) defines "excavation" to be the use of tools or equipment to move or displace earth, rock, or other material in the ground.

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business

trust, public agency, or other entity that, with their own employees or equipment performs any excavation."

Regarding licensed contractors, Business and Professions Code section 7068.1 makes a contractor responsible for the conduct of its subcontractors. At subdivision (a), section 7068.1 states, in part, "The person qualifying on behalf of an individual or firm ... shall be responsible for exercising supervision and control of their employer's or principal's construction operations to secure compliance with this chapter and the rules and regulations of the board."

Section 7068.1 defines "supervision and control" to mean "direct supervision or control or monitoring and being able to assist others to whom direct supervision and control has been delegated." (Bus. & Prof. Code section 7068.1(c)(3).) Further, "direct supervision or control" means any of the following:

- (A) Supervising construction operations.
- (B) Managing construction activities by making technical and administrative decisions.
- (C) Checking jobs for proper workmanship.
- (D) Supervision on construction sites. (Bus. & Prof. Code section 7068.1(c)(4).)

Further, licensed contractors are required to comply with dig-safe laws by Business and Professions Code section 7110, which makes violation of the dig-safe laws a cause for disciplinary action. Section 7110(f) states that "[w]illful or deliberate disregard and violation of the building laws of the state, or of any political subdivision thereof, or of any of the following references to or provisions of law, constitutes a cause for disciplinary action against a licensee: (f) Any provision of Article 2 (commencing with Section 4216) of Chapter 3.1 of Division 5 of Title 1 of the Government Code."

Grey-Con Construction Inc. was hired by South Point Construction LLC to install hardscape for a driveway at 4827 Dorchester Road, Corona Del Mar, California 92625. On August 22, 2024, Grey Con Construction Inc. damaged a natural pipeline with a shovel.

Prime Contractor South Pointe Construction LLC

South Pointe Construction LLC hired Grey-Con Construction Inc. (Grey-Con) to install hardscape for the driveway. (Exh. 2.)

South Pointe Construction LLC is currently licensed by the California Contractor's State License Board, as of April 7, 2025, holding license number 989405 with a B-General Building Classification. (Exh. 3.)

During the investigation, the investigator emailed and mailed information requests, IR-2025-261 and IR-2025-2-114, to South Pointe Construction LLC. However, South Pointe Construction LLC did not respond to the investigator's information request. (Exhs. 4, 5.)

On September 12, 2025, the investigator performed a telephone call to South Pointe Construction LLC at the business number listed on the California Contractor's State License Board website. However, the number was no longer in service. (Exh. 6.)

Sub Contractor Grey-Con Construction Inc.

Grey-Con was digging to install hardscape at 4827 Dorchester Road, Corona Del Mar, California 92625, on August 22, 2024, when the natural gas pipeline was damaged with a shovel. (Exhs. 1, 2.)

Grey-Con is licensed by the California Contractors State License Board, as of December 3, 2024, holding license number 329260, with a C27 – Landscaping classification. (Exh. 7.)

Grey-Con Did Not Contact the Regional Notification Center Before Excavating

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

Grey-Con did not notify the regional notification center prior to excavation. Jeffrey Thomas Greyson, Reporting Managing Officer, Chief Executive Officer, and President of Grey-Con, indicated during his telephone interview with the investigator on December 13, 2024, that the reason he did not contact the regional notification center before excavating was due to the lack of information for his employee to contact the regional notification center prior to excavating. (Exh. 2.)

The Southern California Gas Company indicated in the notification they submitted to the Board that there were marks from a previous ticket. (Exh. 1.)

On December 30, 2024, Investigator emailed Amber Dahl, Safety Awareness Director at the Underground Service Alert of Southern California (DigAlert), requesting ticket information for 4827 Dorchester Road, Corona Del Mar, California 92625, for August 22, 2024. (Exh. 8.)

Safety Awareness Director Amber Dahl responded by email that same day, providing a copy of a ticket associated with 4827 Dorchester Road, Corona Del Mar, California 92625. However, the ticket contained a different business entity, CAL Empire Engineering, as the excavator and did not include Grey-Con. No other tickets were located for February 22, 2024, through August 22, 2022. (Exh. 9.)

Grey-Con Did Not Contact 911 Emergency Services After Damaging the Line

Government Code section 4216.4(c)(1) states an excavator shall call 911 emergency services upon discovering or causing damage to a gas or hazardous liquid pipeline subsurface installation in which the damage results in the escape of any flammable, toxic, or corrosive gas or liquid.

On December 13, 2024, Jeffrey Thomas Greyson, President of Grey-Con, indicated during his telephone interview with the investigator that, while his employee was using a pick on August 22, 2024, Grey-Con damaged a plastic natural gas pipeline by excavating to install hardscape, which caused gas to leak, but did not contact 911 afterward. Jeffrey Thomas Greyson stated he did not contact 911 because he did not know he had to. (Exh. 2.)

On January 13, 2024, the Investigator emailed the Newport Beach Fire Department to request a fire report for 4827 Dorchester Road, Corona Del Mar, California 92625 for August 22, 2024. On January 27, 2024, the Newport Beach Fire Department responded electronically, confirming no reports were located. (Exh. 10)

South Pointe Construction LLC Did Not Contact the Regional Notification Center Before Excavating

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

South Pointe Construction LLC did not notify the regional notification center prior to their sub-contractor, Grey-Con, excavation at 4827 Dorchester Road, Corona Del Mar, California 92625, on August 22, 2024. (Exh. 1.)

Amber Dahl with DigAlert provided the investigator with tickets between the dates of February 22, 2024, through August 22, 2024, where no tickets were provided for Grey-Con when they excavated on August 22, 2024. The reason South Pointe Construction LLC did not notify the regional notification center prior is unknown due to not responding to the investigator's information requests IR-2025-261 and IR-2025-2-114. (Exhs. 4, 5.)

<u>South Pointe Construction LLC Refused to Cooperate with the Board's Investigation</u>
California Code of Regulations, Title 19, section 4151(c) provides that an excavator "who obstructs an investigation by taking actions that were known or reasonably should have been

known to prevent, hinder, or impede an investigation is subject to sanctions under the Act and this division."

On August 6, 2025, Investigator emailed and mailed information request IR-2025-261 to South Pointe Construction LLC. A scheduled response due date was set for August 21, 2025. (Exh. 4.)

The United States Postal Service tracking history indicated information request IR-2025-261 was delivered to the front desk of South Pointe Construction LLC's business address at 12:29 p.m. on August 18, 2025. (Exh. 4.)

On August 25, 2025, Investigator emailed and mailed a 2nd information request, IR-2025-2-114, due to not receiving a response for the first information request, IR-2025-162. A scheduled response due date was set for September 1, 2025. (Exh. 5.)

The United States Postal Service tracking history indicated information request IR-2025-2-114 was unable to be delivered and was returned to the original sender on September 5, 2025. (Exh. 5.)

On September 12, 2025, the investigator attempted to call South Pointe Construction LLC at the business number listed on the Contractor State License Board website. However, the phone number was no longer in service, and voicemail was unable to be delivered. (Exh. 6.)

As of the writing of this Report of Investigation, no information has been provided by South Pointe Construction LLC to the investigator's information requests.

Findings:

- 1. Grey-Con failed to contact the regional notification center before beginning excavation on August 22, 2024, at 4827 Dorchester Road, Corona Del Mar, California 92625 due to the lack of information to its employee.
- 2. Grey-Con failed to contact 911 emergency services to report the escaping gas from the subsurface installation after it was damaged while trenching to expose a facility because the President of Grey-Con did not know he had to contact 911.
- 3. South Pointe Construction LLC failed to contact the regional notification center prior to their sub-contractor beginning excavation on August 22, 2024, at 4827 Dorchester Road, Corona Del Mar, California 92625.
- 4. South Pointe Construction LLC did not respond to the investigator's information request letters.
