gas or liquid.

#### **Executive Summary:**

On July 15, 2024, Picture Build began digging without first contacting the regional notification center and damaged a 0.5-inch plastic natural gas line with a shovel. Upon the escape of gas from the subsurface installation, Picture Build did not call 911 emergency services to report it. No one was injured and no equipment, other than the 0.5-inch plastic natural gas line was damaged.

#### **Notification of the Incident**

On August 16, 2024, at 12:34 p.m., Southern California Gas Company submitted a notification of an incident to the California Underground Safety Board (Board). The notification stated, "Picture Build was hired to install drain line. While digging with hand shovel the 0.5-inch gas service was struck and damaged causing gas leak. No USA for excavation." (Exh. 1.)

The case was assigned to Investigator Ammar Bhatti (Investigator).

#### **Identity of the Excavator**

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust, public agency, or other entity that, with their own employees or equipment performs any excavation."

On November 6, 2024, Investigator sent the Board's Investigation Questionnaire to Picture Build. On November 7, 2024, Jorge, project manager for Picture Build, responded to the Board's Investigation Questionnaire and included the design estimate and photos of the jobsite. (Exh. 2). In the answers to the questionnaire, Jorge stated Picture Build were trenching for drains, using hand tools, at 22232 Dumetz Road, Woodland Hills, California 91364 on July 15, 2024. (Exh. 2.)

In his November 7, 2024, response to the Board's Investigation Questionnaire, Picture Build's project manager Jorge stated that on July 15, 2024, while using a shovel, Picture Build damaged a 0.5-inch plastic natural gas line by hitting it while digging, causing a gas leak, but did not call 911 afterwards. (Exh. 2.)

Picture Build is a licensed contractor, as of April 8, 2025, registered with Contractors State License Board, license number 990772, with C27 – Landscaping, C-8 – Concrete, C53 – Swimming Pool, and B - General Building Classifications. (Exh. 3.)

#### Picture Build Did Not Contact the Regional Notification Center Before Digging

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

Picture Build did not notify the regional notification center prior to excavation at 22232 Dumetz Road, Woodland Hills, California 91364. Project Manager Jorge stated that Picture Build did not contact the regional notification center because, "Additional work was added and done on the fly and forgot to call 811." (Exh. 2.)

On October 31, 2024, Investigator emailed Amber Dahl, Safety Awareness Director at DigAlert, requesting ticket information for 22232 Dumetz Road, Woodland Hills, California for June 1, 2024, through July 31, 2024. (Exh. 4.)

Safety Awareness Director Amber Dahl responded on November 1, 2024, confirming that a ticket did not exist for 22232 Dumetz Road, Woodland Hills, California on July 15, 2024. (Exh. 5.)

#### Picture Build Did Not Call 911 Emergency Services Upon Gas Being Released

Government Code section 4216.4(c)(2) states an excavator shall call 911 emergency services upon discovering or causing damage to a gas or hazardous liquid pipeline subsurface installation in which the damage results in the escape of any flammable, toxic, or corrosive gas or liquid.

When asked on the excavator survey if anyone from Picture Build called 911 after the damage on July 15, 2024, Project Manager Jorge answered, "No." (Exh. 2)

#### **Findings:**

- 1. Picture Build failed to contact the Regional Notification Center before beginning excavation on July 15, 2024, at 22232 Dumetz Road, Woodland Hills, California 91364.
- 2. On July 15, 2024, Picture Build failed to call 911 emergency services to report the escaping gas from the subsurface installation after it was damaged by a shovel.







#### **SCOPE OF WORK\***

Thank you for giving me the opportunity to present this bid; the scope of work is listed below for the backyard and front yard areas. If the project goes into contract; **please note** that if the total square footage goes up or down for any scope of work during the installation, the price will be reflected in a change order as either a credit or addition. This would be established ahead of the installation.
