Executive Summary:

On October 13, 2023, Chandlers Plumbing dug a trench to install a residential electrical facility before notifying the regional notification center. Chandlers Plumbing damaged a ½" plastic natural gas facility, releasing gas into the atmosphere.

No injuries or fatalities were reported.

Investigation:

Notification of the Incident

Chandlers Plumbing submitted a damage notification to the California Underground Safety Board on October 13, 2023. It stated:

"DIG SITE WAS COMPLETE, INSPECTOR THEN TOLD THEM TO DIG AN ADDITIONAL 10IN IN A LOCATION AND IN DOING SO STRUCK A GAS LINE. DAMAGE IN FRONT OF PROPERTY." (Exh. 1.)

The case was assigned to Investigator Jeff McClenahan (Investigator). Additional interviews were done by Investigator Gabrielle Zeps (Investigator Zeps).

Identity of the Excavator

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust, public agency, or other entity that, with their own employees or equipment performs any excavation."

On October 13, 2023, Chandlers Plumbing was trenching with a shovel and an estimated 70-pound "electric hand shovel" to install an electrical line for a homeowner at 2794 Agua Vista Drive, San Jose, California 95132. (Exh. 3, 8.)

Chandlers Plumbing, as of October 30, 2023, held a license issued by the California Contractors State License Board, license number 977412, with C36 Plumbing, C-61/D64-Water Remediation, C27- Landscaping, C-61/D06 Concrete Related Services, and C-61/D49 Tree Service License classifications. (Exh. 2.)

Excavation and Damage

Government Code section Government Code 4216(g) defines "excavation" to be the use of tools or equipment to move or displace earth, rock, or other material in the ground.

On October 13, 2023, Chandlers Plumbing was trenching with an estimated "60 or 70-pound" "electric hand shovel" to install an electrical line for a homeowner (Exh. 8.) at 2794 Agua Vista Drive, San Jose, California 95132. (Exh. 3.)

Ishmael Chandler and PG&E's DiRT Report states that Chandlers Plumbing then used an electrical saw to remove a tree root. (Exh. 3, 8.) At approximately 11:30 a.m., they "sliced" into a ½" plastic natural gas facility owned by Pacific Gas and Electric (PG&E) at 2794 Agua Vista Drive, San Jose, California 95132. (Exh. 3.)

On March 20, 2025, Investigator Zeps had a telephone interview with Spanish speaking Mario Cuevas, master plumber employed by Chandler Plumbing. Vibalita with Focus Interpreting & Translations also participated in the interview to provide Spanish English translations. Mario was working at 2794 Agua Vista Drive, San Jose, California 95132 on October 13, 2023. They had done 2 different things and were ready for the Inspector to come and sign-off that everything was in its place so they could close the trench. The trench was for electric and for water and sewer. The Pacific Gas & Electric (PG&E) Inspector said everything was "ok." But then the PG&E Inspector and the homeowner at 2794 Agua Vista Drive, San Jose, California 95132 told Mario to dig three feet deeper. Mario didn't want to as the gas and the electric were very close. He, however, felt he had to comply as the PG&E Inspector and the homeowner could complain negatively about him to the owner of Chandler Plumbing. He knew the gas line was close, but felt he had to do it. He inadvertently struck the gas line. (Exh. 4.)

There is a conflict in statements between damaging the natural gas facility while cutting tree roots or digging the trench deeper, however photographs provided by PG&E show a trench was created on site. (Exh. 3.)

On March 5, 2025, Investigator Zeps had a telephone interview with Ismeal Chandler, owner of Chandler Plumbing. He had not been present on October 13, 2023, at 2794 Agua Vista Drive, San Jose, California 95132, but certainly remembered it. In summary, he stated: "I want to fight it." Up until that day he had had an A+ safety rating. Our pipe from the ADU was ready, to

grade. They made us dig deeper and made us bust the gas line. I have never hit a gas line – never. I feel like I had a knife to my throat. Never had a problem like this before. The power box was in the ground. The PG&E Inspector marked where we had to dig to dig the box out.

He was making it up as they went; first this and then that. The PG&E Inspector was there as it was the final hook-up of the ADU to PG&E. He has been a plumbing contractor for 10 years and has done lots of digging. We were supposed to dig up to the box. The job was supposed to be ½ & ½ job, but we ended up doing all the work by digging right up to the box. Then this PG&E guy started saying "no – all the way here" "over here" "down to here." The homeowner, the PG&E inspector and Mario were all looking. Mario said you need to take over - there is a gas line. The PG&E Inspector told Mario he needed to go deeper. Mario had just started going deeper when he nicked the gas line. He (Ismeal Chandler) was glad then and is still glad that no one got hurt. He is very disappointed that the PG&E guy had no feelings about the incident and never apologized. They had been at depth, and he told us to dig deeper. Then PG&E billed us \$8,000.00 for the 30 minutes it took to repair the nick. The \$8,000.00 bill really made him feel bullied. (Exh. 5.)

In PG&E's Dig-in Reduction Team (DiRT) Report, their investigator also noted that:

- They did not observe field marks near the damage site
- The crew (Chandler Plumbing) contacted his office (PG&E) to advise they had struck the line
- The property owner contacted 911 and requested emergency services (Exh. 3.)

After the Damage, Chandlers Plumbing Contacted the Regional Notification Center and Obtained a New Ticket and a Damage Ticket

Government code section 4216.2(b) requires an excavator, except in an emergency, to notify the regional notification center of the excavator's intent to excavate at least two working days before beginning excavation.

Approximately 11:40 a.m. on October 13, 2023, Chandlers Plumbing contacted the Regional Notification Center which created ticket 2023101301822-000 (Exh. 6) and damage ticket 2023101301822-001. (Exh. 7.) Both tickets were for 2794 Agua Vista Drive, San Jose, California 95132.

<u>Ticket 2023091302800 Overlapped 2794 Agua Vista Drive But Was Unknown to Chandlers</u> Plumbing

Chandlers Plumbing stated that there were existing locate marks from a ticket unknown to them at the time of excavation and they used them. (Exh. 8.) Chandler provided Investigator with a photograph of the existing locate marks in the area. (Exh. 9.)

Daleo Inc. was installing gas facilities for PG&E in an area that included 2794 Agua Vista Drive in San Jose, California, on ticket 2023091302800 which was active at the time of the damage, October 13, 2023. (Exh. 10. and 11.)

Findings:

1. On October 13, 2023, Chandlers Plumbing failed to contact the Regional Notification Center and obtain a ticket prior to digging a trench with an electric hand shovel.

Investigation Narrative/Field Notes (PG&E Internal Use Only)

INVESTIGATION:

On 10/13/2023 at 1046 hours, I received notification from PG&E Dispatch regarding a possible dig-in to PG&E's gas facilities at the above address. I responded and arrived at 1115 hrs.

Upon arrival, GSR advised third party contractor crew struck and damaged 1/2" plastic gas service causing a release of gas; faded USA field marks were observed near the site. I completed a search of USA current/recent USA tickets at Agua Vista Drive, San Jose; no active or expired USA ticket were found at residence/and damage site.

I contacted Chandlers Plumbing Owner Ismael Chandler; he told me his company was hired by the property owner to excavate for an updated electrical panel. Prior to excavation, he observed (prior) PG&E USA field marks along the sidewalk in front of the residence (field marks associated to unrelated contractor). No field marks were observed near the damage site. He told me today, his crew arrived on site and began digging north of the driveway to install electrical conduits. This morning, his crew was hand digging to an approximate depth of 36" when they began to expose numerous tree roots at the bottom of the trench. Laborer Mario (Cuevas) was using a reciprocating saw to remove the tree roots; he began cutting a

large root when he struck and damaged a buried gas line causing a leak. The crew contacted his office to advise they struck a gas line. The property owner contacted 911 and requested emergency services.

I asked Chandler if he or his company (Chandler Plumbing) had obtained a USA ticket prior to excavation; he told me "No, I don't think so." I explained there was no valid USA ticket for Agua Vista Drive, San Jose. I explained contractors are required to contact 811 prior to excavation and wait for positive response (proposed excavation site). He told me his company would cease excavation and contact 811 prior to resuming excavation.

CONCLUSION:

On October 13, 2023 an employee of Chandlers Plumbing damaged 1/2" plastic gas service during power excavation causing release of gas. The 1/2" plastic gas service was struck and damaged with reciprocating saw causing a release of gas. This dig-in was a direct result of Chandlers Plumbing failing to obtain a USA ticket prior to excavation in violation of California Government Code 4216.2 (b).





Note: I called Mario and explained why I was calling. I put him on hold while I called the interpreter. While arranging for the interpreter services with Focus, Mario hung up. Once I had Vibalita on the phone, I called Mario again and connected the three of us.

INTERVIEW: In Summary

Please tell him that I want to understand what happened at this jobsite. Nothing that he tells me today is going to get him in trouble.

Q: Do you remember this jobsite?

A: Yes - I remember the address.

Q: What were your original directions?

A: Everything was fine. I connected to the main drain. I was working in the back of the house in the yard. Everything was good. The inspector came.

Q: Why did the Inspector come?

A: Every time we do that type of job, an inspector comes to see if everything is in place. He came to see if everything was in place.

Q: Is The inspector usually from the City or PG&E?

A: I don't know the question. Doing the electric part to the drain from the back of the house. We did 2 different things: open trench for electric and for water & sewer.

Q: So, you had both of those parts done before you called the inspector?

A: Inspector was before the hole. Had to be ok for everything so that it could be closed.

Q: Was he ok with everything?

A: He was ok.

Q: Did he ask you to dig more?

A: It was impossible to dig more. The pipe was too close to that.

Q: While the inspector was there, was there any damage to the NG pipeline?

A: We were talking more. Dig more. Problem with the gas. The guy in the house asked us to dig more. Can't because of the pipe.

Q: Explain where the gas pipe was re: where you were digging.

A: The gas and the electric were very close to each other.

Q: What does that closeness have to do with what he was doing?

A: The owner wanted me to dig more. When we tried, he insisted. Fire trucks came to fix it.

Q: Who else was part of this conversation?

A: The inspector told him (Mario) to dig 3 feet. Both the inspector and the homeowner.

Q: Was that 3 feet deeper or longer?

A: Deeper.

Q: What did the inspector say after the damage happened?

A: The one from PG&E – working for the electricity – asked me what I was doing?

Q: Was anyone other than you (Mario), the inspector, the homeowner present?

A: Another person was helping him dig and the fire company.

Q: Did you call your boss and ask if the 3 feet was part of your job?

A: When they fix the gas problem, roots, do the job like expected.

Q: Was digging that 3 feet deeper part of the original contract?

A: Yes, because the house in the back wanted more power.

Q: I am confused. Why call for the inspector if there was still 3 feet to be dug?

A: The owner told me....told me the inspector wanted 3 feet deeper. I didn't want to as it was very close to the gas.

Q: I don't want to be rude but if you didn't want to do it, why did you?

A: Because he was my boss, and he gave me orders.

Q: The owner was your boss?

A: I was receiving orders from my boss. Inspector and owner. You have to go deep. I knew it was close.

Q: He did feel that the owner and the inspector were his bosses then?

A: I have my boss. They not my boss. They can talk to my boss. Because the gas was very close. 2 guys. If I don't obey, they could complain to my boss. My boss knows everything that happened.

Q: But he wasn't there – you were.



Who from your team was on site at the time of the accident?

1 person – Mario I think.

And what happened?

Doing this for 20 years, never hit a gas line. Had a trench ready for inspection. I wasn't there at that inspection. The inspector insisted that dig deeper near the meter box. In the beginning said didn't have to dig to that meter box. I said hey the gas line is here. Why would want us to go deeper, already to grade. Stuck between a rock and a hard place.

Gas line was clipped immediately after went deeper.

Came to find out that they were replacing that gas line. Came back after they shut the gas off.

They had a project already lined up to replace that gas line. We could have done this the same day as the shutoff. That was 1 or 2 days after the incident.

Felt like was setup. Never worked with them before.

Was a bad experience. Safely dug the trench and got to grade.

The guy from PGE was I dunno, didn't matter to him.

The photo you shared has a yellow gas mark?

The gas mark was there and running to the left of the trench. Was basing that off. We dug correctly and believe should have passed.

Guys were replacing that box later day.

Who was the inspector you mentioned?

PG&E inspector.

We were digging a trench for the electrical line for the main panel. We are a general contractor. We built an ADU in the back and this was like the final thing. And then PGE comes in and PGE comes in to inspect that. This is to grade for the new electrical.

Do you know the USA ticket that was for those marks? No.

So you come to find out later that the marks were for the replacement part of this?

Can you tell me anything about the ongoing work?

Ongoing work, they were replacing the gas lines throughout the entire street.

Did the inspector say the reasoning to go deeper or anything like that?

Those guys were going to do that digging anyway. They had me pissed. Been through thousands of inspections through San Jose, but our first year general contracting.

What were you working with or your guy when your team hit the gas line?

Was cutting roots with the sawsall, redwood tree right there.

You didn't have the USA Ticket, were going off the lines there?

Yes. Normally pull it, but the lines were already in the scope of the gas line. We had inspection of PGE and came with it to grade.

You said you built the ADU in the back? So how did you know where the electrical was?

Electrical knew from the ADU to the panel.

What equipment use to do the trench?

That was all hand digging and then had the electric hand shovel to do that as well. Like the Bosch, small one, sixty seventy pounds but not sure the exact one.

And you created a damage ticket?

Yeah, PGE told me to do that and put that in the same day.

And now, 2 days later the entire gas line was replaced, so not even a repair there.

Did you know anything about the gas line replacement?

I didn't andthe homeowner did either.

Anything else to share?

Glad nobody got hurt and there wasn't any damage to the property.
