Adrian,

Good morning. I am responding to a "Notice of Probable Violation" dated September 26th, 2025 and Request for Information letter N2424853.

Last night was the first hearing on an investigation or request for information. The following will explain why.

- In early April, I laid off by director of operations, Mariana Saldana. She was the sole recipient of the email address you were sending the requests to, "info@southpointeinc.com" (see attached screenshot). When I let her go I was not even aware that she was getting these emails. It is listed on our website but for a long time it only received spam and I honestly thought it had been shut down.
- The mailing address (31805 Temecula PKWY D7-763, Temecula Parkway, CA 92592) that you have for us is also an old address. In Jan. 2021 we stopped working in Temecula and changed our address to 23 Corporate Plaza Suite 150, Newport Beach, CA 92660.
- In April of this year, (same time I let go of Mariana), I changed our mailing address again to (3334 E
 Coast Highway #743, Corona Del Mar CA 92625). Sometimes it is a long process to get mail that is
 sent to the old addresses. Mariana didn't update our company phone number or mailing address
 before her final day.

That explains why I have not responded.

As for the information requested. See responses below in bold.

- 1. Was SPC the prime contractor for the projects at 4827 Dorchester, Corona Del Mar, CA 92625? Yes.
- 2. Did South Pointe Construction LLC, hire Green-Con Construction DBA Grey-Con Landscape Construction (Grey-Con)? Yes.
- a. Provide a summary of work Grey-Con was hired to do. New Flatwork and area drain lines.
- b. Provide a copy of the contract between SPC and Grey-Con. Attached.
- 3. Did SPC contact the regional Notification Center on August 22, 2024? NO
- 4. Did SPC create an 811 ticket for 4827 Dorchester Rd., Corona Del Mar prior to excavation occurring on August 22, 2024 No, there were old markings that were still visible.
- 5. Did SPC direct Grey-Con to contact the regional Notification Center prior to excavating at 4827 Dorchester, CA prior to excavation occurring on August 22, 2024. It is very likely, but I have no way of determining this at this point. Standard practice is that all subcontractors digging on property call 811 before starting. There were old markings so the field team might have thought that was adequate to proceed with the work activities that day.
- 6. Was SPC onsite when the incident occurred? I don't know. The superintendent managing the project at that time no longer works at for me.
- 7. How was SPC notified of the damage to the natural gas line? I do not know.
- 8. What did SPC do once damage to the natural gas line occurred. **The superintendent called SoCal Gas to repair the line. I am not sure what additional measures were taken. The superintendent doesn't work for me any longer.**
- 9. Provide a summary of what SPC observed when the incident occurred. A worker for Grey-Con construction hit an existing gas line near the front left corner of the house while digging with hand tools. The line was unusually shallow. The worker capped the line. My superintendent called SoCal Gas to make repairs and I believe the workers cleared the site.
- 10. Did SPC contact Souther California Gas Company after damage to the gas line occurred. Yes.
- 11. Did SPC contact call 911 on August 22, 2024 after the damage occurred No.
- a. Why did SPC not Call 911 on August 22, 2024 after damage occurred? No one was injured, no property was damaged other than the gas line.

I hope the provides you everything you need. I see there is a link for a safety training that I will go to now.


