Government Code § 4216.2(b): Excavating without first notifying the regional notification center of intent to excavate.

**Executive Summary:**

On July 8, 2024, Verne's Plumbing Inc. trenched with an excavator bucket without first contacting the Regional Notification Center and damaged a 2" natural gas facility. Upon the escape of gas from the subsurface installation, emergency services responded to the incident. No one was injured and no equipment, other than the 2" natural gas facility, was damaged.

**Investigation:****Notification of the Incident**

On July 16, 2024, Southern California Gas Company submitted a notification of an incident to the California Underground Safety Board. The notification stated, Verne's Plumbing damaged a "main" and did not have a valid USA ticket. (Exh. 1.)

The case was assigned to Investigator Jeff McClenahan (Investigator).

**Identity of the Excavator**

Government Code section 4216(g) defines "excavation" to be the use of tools or equipment to move or displace earth, rock, or other material in the ground.

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust, public agency, or other entity that, with their own employees or equipment performs any excavation."

Verne's Plumbing Inc. was performing work with an excavator and they "chipped" the facility with a "smooth bucket" at Paloma Valley High School at 31375 Bradley Road Menifee, California 92584. (Exh. 2.)

Verne's Plumbing Inc. is currently licensed by the California Contractor's State License Board, license number 674077 with C-34 Pipeline, C-36 Plumbing, and B – General Building Classification[s]. (Exh. 3.)

**Excavation Damage**

On July 8, 2024, Verne's Plumbing Inc. damaged a 2" natural gas facility by trenching with an excavator bucket. (Exhs. 1, 2.)

Verne's Plumbing Inc., in the survey response to the investigator, confirmed it was excavating with a "backhoe/trackerhoe/excavator" and shovel and that the crew clipped the natural gas facility with the smooth excavator bucket. (Exh. 2.) This is consistent with the notification from Southern California Gas Company, photographs included below. (Exh. 1.)

**Verne's Plumbing Inc. Did Not Contact the Regional Notification Center Before Excavating**

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

On July 8, 2024, Verne's Plumbing Inc. damaged a 2" natural gas facility by trenching with an excavator bucket. (Exhs. 1, 2.)

Verne's Plumbing Inc. did not notify the regional notification center prior to excavation at 31375 Bradley Road Menifee, California 92584.

In November 2023, Verne's Plumbing obtained ticket A233120968-00A for trenching work at 31375 Bradley Road Menifee, California 92584. Ticket A233120968-00A was not renewed. (Exh. 6.)

On July 8, 2024, the afternoon of the damage, Verne's Plumbing contacted DigAlert and received new ticket A241901002-00A. (Exh. 6.)

The reason that Lyle Ferguson, Vice President of Verne's Plumbing stated they did not contact the regional notification center prior to use of the excavator was that the foreman forgot to "update" the ticket and that there were no longer locate markings visible due to the removal of the asphalt. (Exh. 2.)

On September 24, 2024, Investigator emailed Amber Dahl, Safety Awareness Director, at DigAlert requesting a copy of tickets A233120968-00A and A241901002-00A. (Exh. 4.)

Safety Awareness Director Dahl responded on September 25, 2024 with a copy of the two tickets and stated that there were no further tickets related to those tickets. (Exh. 5.)

### **911 Emergency Services was Contacted Upon Gas Release**

Government Code section 4216.4(c)(2) states an excavator shall call 911 emergency services upon discovering or causing damage to a gas or hazardous liquid pipeline subsurface installation in which the damage results in the escape of any flammable, toxic, or corrosive gas or liquid.

The investigation was unable to determine the source of the 911 call, however the City of Menifee did have a record of an emergency response.

On July 8, 2024, while using an excavator, Verne's Plumbing Inc. damaged a 2" natural gas facility by trenching with an excavator bucket. (Exhs. 1, 2.)

On December 20, 2024, the investigator requested a copy of dispatch logs from the City of Menifee through their online portal. (Exh. 9.)

On December 30, 2024, the investigator received a public records response from the Menifee Police Department containing a dispatch log of the emergency response to a "ruptured gas line" at 31375 Bradley Road Menifee, California 92584. (Exh. 8.)

### **Findings:**

1. On July 8, 2024, Verne's Plumbing Inc. damaged a 2" natural gas facility by trenching with an excavator bucket.
2. Verne's Plumbing Inc. failed to contact the Regional Notification Center before beginning excavation on July 8, 2024 at 31375 Bradley Road Menifee, California 92584 because they did not renew an existing ticket or create a new ticket prior to excavation.
3. There was an emergency response to the facility damage and gas release at 31375 Bradley Road Menifee, California 92584.
