**RE: PacifiCorp (U 901 E) Third Quarter 2025 Wildfire Mitigation Plan
Quarterly Data Report - Resubmission**

Dear Director Jacobs:

PacifiCorp d/b/a Pacific Power (PacifiCorp or the company) submits its third quarter (Q3 2025) Quarterly Data Report (QDR) pursuant to Energy Safety's Final Wildfire Mitigation Data Guidelines – Version (v) 4.01 (WMP Data Guidelines) adopted on February 28, 2025, and issued on March 21, 2025.

The company notes the following regarding the third quarter 2025 QDR:

- Feature classes 'Vegetation Inspection Line' and 'Vegetation Management Project Line,' which were previously included in the first and second quarter 2025 QDRs, are not in the third quarter geospatial filing; they have been replaced with the 'Vegetation Inspection Point' feature class.
- Following the July 21, 2025, Energy Safety Compliance Guidelines Workshop, Energy Safety Compliance Division requested PacifiCorp provide Field Notes in the QDR geospatial filing for the initiatives listed below. PacifiCorp is developing system and process changes to provide these notes for these initiatives and will provide them in the first quarter 2026 QDR for all of the initiatives except 8.1.2.8, Installation of System Automation Equipment.
 - 8.1.2.3 Distribution Pole Replacement and Reinforcement
 - 8.1.2.12 Expulsion Fuse Replacement
 - 8.1.2.4 Transmission Pole/Tower Replacements and Reinforcements
 - 8.3.2.1 Existing Systems, Technologies, and Procedures
 - 8.1.2.8 Installation of System Automation Equipment
 - 8.1.2.1 Line Rebuild program - Covered conductor installation
 - 8.1.2.2 Undergrounding of electric lines and/or equipment

- In the third quarter resubmission of the data tables on November 21, 2025, a correction was made in Table 1, cell AE12. The status of this initiative has been changed to 'Completed' for the re-filing, it was previously reported as 'In Progress.' This corrected information is now consistent with PacifiCorp's second quarter submittal for the initiative shown below:
 - 8.5.2 Partner with public safety partners in communities throughout California regarding wildfire safety and preparedness and PSPS.
